Program biologists, along with 64 volunteers, monitor waterbird colonies, collect data on waterbird distribution, and document disease outbreaks. These data are especially effective in tracking trends in our local bird populations and helping to guide wetland restoration in the Bay Area.4b (Code: ☐) (Expenses \$ 68,720. including grants of \$) (Revenue \$ 31,597.)The Snowy Plover Recovery Project works towards the recovery of the federally threatened Western Snowy Plover. Biologists monitor Snowy Plover populations by surveying the salt ponds of the San Francisco Bay where the birds breed. Program biologists work closely with local land managers and restoration projects to implement management practices to help increase the Snowy Plover population in the Bay.4c (Code: ☐) (Expenses \$ 40,049. including grants of \$) (Revenue \$ 29,353.)The Riparian Bird Program monitors birds that depend on healthy creek habitats in the San Francisco Bay Area. At our research center, the Coyote Creek Field Station, we use the science of bird banding to track avian response to document long-term demographic trends in this habitat. Most of the data are collected by 40 highly-trained volunteers. These data are imperative to conserving and restoring riparian habitats and contributing to our knowledge of avian response to climate change.
